

SECOND AMENDED ELECTION ORDER

On this, the **28th day of August, 2024**, the Board of Navigation and Canal Commissioners of Galveston County Navigation District No. 1 adopted the following resolution:

“BE IT RESOLVED THAT, WHEREAS, in accordance with the applicable sections of the Water Code of Texas, the Election Code of Texas, and the resolutions heretofore adopted by the Board of Navigation and Canal Commissioners (Board) pursuant thereto, the term of office of a member of the Board, to-wit: TED FARMER, JR., will expire by operation of law on the **5th day of November, 2024**, on which date a Navigation and Canal Commissioner (“Commissioner”) is to be elected to fill that position; and

“WHEREAS, it is required by law that said Board pass an order calling such election and governing the conduct of same.

“NOW, THEREFORE, BE IT ORDERED by the Board of Galveston County Navigation District No. 1, as follows:

1. An election shall be held on **November 5, 2024** for the purpose of electing one Commissioner to the Board for a term of six (6) years. It shall be held jointly with the General Election for State and County offices.
2. All qualified persons desiring to stand for election to said office must apply to the Secretary of said Board not later than 5:00 p.m. on **September 9, 2024** to have their names placed on the ballot. In addition, a candidate's name may be placed on the ballot by filing a petition of 20 or more qualified electors of the Galveston County Navigation District No. 1 (“District”) with the Secretary of said Board by such deadline of **September 9, 2024**. An application may not be filed earlier than **July 20, 2024**.
3. All qualified persons desiring to stand for election to said office must apply to the Secretary of said Board not later than 5:00 p.m. on **September 16, 2024** to have their names printed on the ballot. In addition, a candidate's name may be printed on the ballot by filing a petition of 20 or more qualified electors of the Galveston County Navigation District No. 1 (“District”) with the Secretary of said Board by such deadline of **September 16, 2024**. An application may not be filed earlier than **July 20, 2024**.
4. Notice of this election shall be published once a week for two consecutive weeks in The Galveston County Daily News.
5. All early voting shall be conducted in accordance with the provisions of the Texas Election Code and the procedures, locations and days and hours of early voting shall be the same as shall be established for the general election for state and county offices, to be held **November 5, 2024** (“General Election”).

(A) Early voting by mail may be sent only to the **Galveston County Elections Office, 10000 Emmett F. Lowry Expressway, Suite 1152, Texas City, Texas 77591**; and

(B) The polling places for early voting in person commencing **October 21, 2024** are designated to be at the Early Voting Locations designated by the Commissioners' Court of Galveston County for purposes of the General Election.

Dates, times, and locations for polling places are as follows:

SEE ATTACHED **EXHIBIT "A"**, WHICH IS INCORPORATED HEREIN BY REFERENCE FOR ALL PURPOSES.

6. The election shall be held in accordance with the applicable provisions of the Texas Election Code, save in instances where such provisions are modified by the Water Code of Texas. The election officers of each election precinct who have been appointed to serve for the General Election are appointed to serve in the same offices for this election. The election precincts are designated to be the same as those established by the Galveston County Commissioners Court for the General Election. Precinct No. 224 shall include only such voters residing east of 103rd Street. The polling places within said precincts are those designated by the Galveston County Commissioners Court for the General Election and are those listed and enumerated in the attached **Exhibit "A"**. Polls shall be opened at 7:00 a.m. for voting and shall be closed at 7:00 p.m. on **November 5, 2024**. The presiding and alternate judges for each election precinct shall be the same persons as appointed for the General Election.

7. Inasmuch as more than five percent (5%) of the citizens of voting age residing within the boundaries of the District are members of a single language minority, to-wit, Spanish, the applicable provisions of 42 U.S.C.A., 1973aa-1 and Chapter 272 of the Election Code of Texas are applicable to the conduct of the election.

SEGUNDA ORDEN ELECTORAL ENMENDADA

El día de hoy, el día **28 de agosto de 2024**, la Junta de Navegación y Comisionados del Canal del Distrito de Navegación No. 1 del Condado de Galveston adoptó la siguiente resolución:

“SE RESUELVE QUE, CONSIDERANDO que, de conformidad con las secciones aplicables del Código de Aguas de Texas, el Código Electoral de Texas y las resoluciones adoptadas hasta ahora por la Junta de Comisionados de Navegación y Canal (Junta) de conformidad con los mismos, el mandato de un miembro de la Junta, a saber: TED FARMER, JR., expirará por ministerio de la ley el **día 5 de noviembre de 2024**, fecha en la cual se elegirá un Comisionado de Navegación y Canal (“Comisionado”) para ocupar ese puesto; y

“CONSIDERANDO que la ley exige que dicha Junta apruebe una orden convocando dicha elección y que rija la realización de la misma.

“AHORA, POR LO TANTO, LA Junta del Distrito de Navegación No. 1 del Condado de Galveston ORDENA lo siguiente:

1. Se llevará a cabo una elección el **5 de noviembre de 2024** con el fin de elegir un Comisionado a la Junta por un período de seis (6) años. Se llevará a cabo conjuntamente con la Elección General para cargos estatales y del condado.
2. Todas las personas calificadas que deseen presentarse a las elecciones para dicho cargo deben solicitar al Secretario de dicha Junta a más tardar a las 5:00 pm del **9 de septiembre de 2024** que sus nombres se incluyan en la boleta. Además, el nombre de un candidato puede incluirse en la boleta presentando una petición de 20 o más electores calificados del Distrito de Navegación No. 1 del Condado de Galveston (“Distrito”) ante el Secretario de dicha Junta antes de la fecha límite del **9 de septiembre de 2024**. . No se podrá presentar una solicitud antes del **20 de julio de 2024** .
3. Todas las personas calificadas que deseen presentarse a las elecciones para dicho cargo deben solicitar al Secretario de dicha Junta a más tardar a las 5:00 pm del **16 de septiembre de 2024** que sus nombres se impriman en la boleta. Además, el nombre de un candidato puede imprimirse en la boleta presentando una petición de 20 o más electores calificados del Distrito de Navegación No. 1 del Condado de Galveston (“Distrito”) ante el Secretario de dicha Junta antes de la fecha límite del **16 de septiembre de 2024**. . No se podrá presentar una solicitud antes del **20 de julio de 2024** .
4. El aviso de esta elección se publicará una vez a la semana durante dos semanas consecutivas en The Galveston County Daily News.
5. Toda votación anticipada se llevará a cabo de acuerdo con las disposiciones del Código Electoral de Texas y los procedimientos, lugares, días y horas de votación anticipada serán los

mismos que se establecerán para las elecciones generales para cargos estatales y del condado, que se celebrada **el 5 de noviembre de 2024** (“Elecciones Generales”).

(A) La votación anticipada por correo puede enviarse únicamente a la **Oficina de Elecciones del Condado de Galveston, 10000 Emmett F. Lowry Expressway, Suite 1152, Texas City, Texas 77591** ; y

(B) Los lugares de votación para la votación anticipada en persona a partir **del 21 de octubre de 2024** están designados para estar en los lugares de votación anticipada designados por el Tribunal de Comisionados del Condado de Galveston para los fines de la Elección General.

6. La elección se llevará a cabo de acuerdo con las disposiciones aplicables del Código Electoral de Texas, salvo en los casos en que dichas disposiciones sean modificadas por el Código de Aguas de Texas. Los funcionarios electorales de cada distrito electoral que han sido designados para servir en las Elecciones Generales son designados para desempeñar los mismos cargos en esta elección. Los distritos electorales están designados para ser los mismos que los establecidos por el Tribunal de Comisionados del Condado de Galveston para las Elecciones Generales. El Precinto No. 224 incluirá únicamente a los votantes que residan al este de 103rd Street. Los lugares de votación dentro de dichos precintos son aquellos designados por el Tribunal de Comisionados del Condado de Galveston para las Elecciones Generales y son los listados y enumerados en el **Anexo “A”** adjunto . Las urnas se abrirán a las 7:00 am para la votación y se cerrarán a las 7:00 pm del **5 de noviembre de 2024** . Los jueces presidente y suplentes de cada distrito electoral serán las mismas personas designadas para la Elección General.

7. En la medida en que más del cinco por ciento (5%) de los ciudadanos en edad de votar que residen dentro de los límites del Distrito sean miembros de una minoría de un solo idioma, a -saber, el español, se aplicarán las disposiciones aplicables de 42 USCA, 1973aa1 y el Capítulo 272 de el Código Electoral de Texas son aplicables a la realización de la elección.
